Deans, Directors, Department Chairs, and Administrative Officers:

As you know, Brian Copenhaver has decided to step down from the position of Provost of the College of Letters and Science on June 30, 2003. As he indicated in his September 2002 memorandum, Brian has devoted a large portion of his career to academic administration, and he now wishes to devote more time to teaching and research. We are grateful for his ten years of distinguished leadership of the College.

I have taken this opportunity to reconsider the use of the "Provost" title at UCLA, given that most universities reserve this title for the chief academic officer and principal deputy to the Chancellor or President. At UCLA and generally across the UC system, that principal deputy is the Executive Vice Chancellor.

I have received approval from the Office of the President to make the following title changes at UCLA, effective July 1, 2003: Executive Vice Chancellor to Executive Vice Chancellor and Provost; Provost of Medical Sciences to Vice Chancellor, Medical Sciences; and Provost, College of Letters and Science to Executive Dean, College of Letters and Science. As a result of these changes, there will be additional title changes within the College (see attachment).

To assist me in selecting Brian Copenhaver's successor, who will hold the title of Executive Dean of the College, I have appointed a search committee under the chairmanship of Vice Chancellor Emeritus and Professor of Law, Norman Abrams.

I ask Department Chairs in the College to distribute this letter to faculty colleagues in your respective departments. Thank you in advance for your assistance and cooperation as we make this important transition.
